Agenda of the Day and Resolutions:

- (i) Approval of the minutes of the 178th Meeting of the Fiscal Council. The councilors unanimously approved the said minutes.
- (ii) Analysis of the Financial Statements for the third quarter of fiscal year **2018**. The CFO and Investor Relations Officer, Rinaldo Pecchio Junior and the Accounting Manager, Carisa Santos Portela Cristal, presented the principal highlights of the results for the period.

The representative from Ernst & Young, Marcos Quintanilha, informed of his replacement by Adilvo França Júnior, as partner responsible for reviewing the Company's financial statements. Subsequently, the principal highlights of the quarter were presented.

In the exercising of its legal and statutory duties, and pursuant to the provision in sub-section iv, Article 163 of Law 6.404/76, the Company's Fiscal Council declared that it had examined the Financial Statements for the quarter ending September 30, 2018 and the Report on the Financial Statements of the independent auditors, Ernst & Young Auditores Independentes SS., manifesting favorably as to their disclosure through an Opinion signed on this date.

(iii) General Information on the Company. Reynaldo Passanezi Filho presented the facts of most significance occurring at the Company to the Collegiate Body since the last meeting of the Fiscal Council.
