Analysis of the Financial Statements related to the third quarter of fiscal year 2020. Alessandro Gregori Filho presented the highlights of the financial results according to the International Financial Reporting Standards (IFRS), while Carisa Santos Portela Cristal presented the Income Statement and the Statement of Cash Flows of the Company for the period ended September 30, 2020. After the presentations and clarifications made by the representative of the independent audit firm Ernst & Young Auditores Independentes S.S., the members of the Fiscal Council of the Company, exercising their legal and statutory duties and in compliance with article 163 of Federal Law 6,404/76, examined the Financial Statements related to the quarter ended September 30, 2020 and unanimously decided that the documents could be approved.
